CONDITIONS OF PARTICIPATION

The Terms and Conditions of Participation of Silicon Alps Cluster GmbH (hereinafter referred to as SAC) apply to all legal relationships between SAC and the booking company (hereinafter referred to as UN), which are mutual business transactions within the meaning of the Austrian Commercial Code (UGB). Any deviations from these Terms and Conditions of Participation shall only apply, insofar as these have been confirmed in writing by the SAC.

Registrations will be treated according to the number of places still available and will be ranked according to the time of receipt by the SAC. The number of participants is limited. The date and time of the e-mail, fax or the receipt stamp of the registration form shall be decisive.

The UN is bound to its booking from receipt of the registration form by the SAC up to and including 8 October 2025. If the UN cancels the booking, it is obliged to comply with the SAC's cancellation conditions at (registration form, page 3).

If a registration can no longer be considered due to the limited number of participants, the respective UN will be informed of this by the SAC. As soon as the SAC becomes aware that the registration cannot be considered, the UN is no longer bound by its booking.

The receipt of the registration form by the SAC does not constitute a contract. The contract is only validly concluded by written confirmation of the registration form with acceptance of these conditions of participation by the SAC (acceptance of the booking).

The amount to be paid by the UN is due for payment within 14 days of receipt of the invoice sent by the SAC to. The SAC reserves the right to withdraw from the contract for any reason whatsoever. Cancellation of the contract shall not give rise to any warranty claims or claims for damages. Any transfer of rights arising from this contract to third parties, in particular the transfer of stand space, is not permitted without the consent of SAC.

SAC is authorised to restrict or change the stand space provided to the extent necessary, in accordance with the exhibition management's grid dimensions, due to technical or design conditions and the overall appearance of the exhibition stand.

Additional orders and changes to the UN will be charged. Services ordered in Austria but not accepted or cancelled by the UN's stand management on site at will also be charged. The SAC is responsible for the overall appearance of the exhibition stand. In order to ensure a uniform overall appearance, the use of company-owned stand construction material, such as roll-ups and posters, as well as the commissioning of own stand construction companies by the UN is not permitted. The SAC is responsible for deciding on the number and footprint of roll-ups in the Gold and Silver Packages. The UN itself is responsible for the packaging and transport of the exhibition goods, as well as for the removal of the exhibition goods and for the disposal of the packaging after the end of the trade fair.

All costs for insurance of exhibition goods, which are prescribed by the exhibition organiser, are to be borne by the respective insured party.

For the playing of copyrighted music, protected audio-visual presentations, etc. at the exhibition stand, the UN must first submit written authorisation from the copyright holder or the respective collecting society (e.g. AKM) to the SAC or pay all fees incurred directly to.

The SAC accepts no liability whatsoever for publications, performances, presentations, exhibits, advertising, marketing, provision of information, advice, etc. or other activities or appearances of the UN and the UN undertakes to indemnify and hold the SAC harmless in the event of infringements of rights and liability claims by third parties.

The SAC accepts no liability whatsoever for any items provided or handed over by the UN. Liability of the SAC for damages of any kind due to slight negligence is expressly excluded.

Austrian law shall apply exclusively. The UN Convention on Contracts for the International Sale of Goods is expressly excluded. For any disputes arising from this legal relationship, including those concerning the existence or non-existence of this legal relationship, the competent court in Graz, Austria, is agreed.

All contractual agreements, including collateral agreements, must be in writing in order to be valid. If individual provisions of this contract should be invalid, the validity of the remaining provisions shall not be affected. The invalid provision shall be replaced by a valid provision that comes as close as possible to the intended purpose.

Note: In the event of a dispute, the German version of the terms and conditions applies.
